ADMINISTRATIVE MATTERS

Index to USEUCOM Publications, Policy Memorandums and Forms

1. **Summary.** To provide a current list of USEUCOM Publications and Policy Memorandums, provide guidance on review procedures and information for requisitioning.
 2. **Applicability.** This USEUCOM Pamphlet applies to all HQ USEUCOM publication account holders.
 3. **Explanation of Terms.**
 - a. **USEUCOM Directive (ED)** is a publication which establishes and announces policy, assigns responsibilities, prescribes procedures, and directs actions for USEUCOM activities, internal and external to the Headquarters, to include component commands.
 - b. **Staff Memorandum (SM)** is a USEUCOM publication which establishes and announces policy, assigns responsibilities, prescribes procedures, and directs actions for two or more directorates/staff offices within HQ USEUCOM. An SM may also be applicable to local activities supporting or associated with HQ USEUCOM.
 - c. **USEUCOM Pamphlet (EP)** is a publication which is non-directive in nature and provides information to the HQ USEUCOM staff and/or USEUCOM activities command-wide. It is intended for relatively permanent information.
 - d. **USEUCOM Policy Memorandum** is a letter, memorandum or message which establishes and announces policy, assigns responsibilities, prescribes procedures and directs actions of a temporary nature for USEUCOM activities, internal and external to the Headquarters, to include component commands.
 - e. **USEUCOM Supplement** is a publication used to supplement guidance published by DoD, Service Departments and Component Commands to promulgate additional information.

- This Pamphlet supersedes EP 5-1, dated 20 Sep 2000.
- f. **Form.** A form is a fixed arrangement of captioned spaces designed for entering and extracting prescribed information, regardless of media.

g. **Command Form.** A USEUCOM wide form designated as an **EU Form**. These forms are for use at HQ, USEUCOM by two or more directorates/staff offices and/or all associated units, including component commands. A prescribing Directive (ED) or Staff Memorandum (SM) is required for command forms.

h. **Local Form.** Directorate/Staff Office/Joint Task Force form used by **one** organizational element which uses the symbol of the activity; i.e., ECJ1 Form 1. These forms do not require a prescribing directive or staff memorandum. The numbering system may be numbers from a Standard Operating Procedure (SOP) or a numerical sequence.

i. **Staff Office.** For the purposes of this Directive, Staff Offices are elements of HQ, USEUCOM that are not Directorates; i.e. ECIG, ECPA, ECCS-OR, SAOs, ULCCs, etc. Divisions or Branches of a Directorate are not considered staff offices.

6. **Explanation of Symbols.**

*** Indicates new, revised or changed publications since the last printing of this index.**

Indicates publication must be obtained from the OPR.

@ Indicates publication is over due for revision and will be rescinded NLT 31 Dec 02.

& Indicates publication is under revision by the OPR. Current edition is valid until revision completed.

** Indicates form is available in electronic format on the HQ, USEUCOM ULAN and SLAN.

7. **Review Procedures.**

a. **Yearly Review Cycle.** OPRs are required to review publications/forms for which they are responsible once a year. This review is to insure accuracy and validity. Publications/forms found to be inaccurate or no longer valid will be rewritten or rescinded by the OPR. ECJ1-AA will not

provide OPRs with a reminder notice of their publications/forms that require review. Publications not rewritten or rescinded by the OPR by the end of the 5th year will be automatically rescinded by ECJ1-AA.

b. **Five Year Review Policy.** In addition to the annual review, OPRs are required to rewrite or rescind publications for which they are responsible during the fifth anniversary year of the **basic** publication (i.e. all publications published in 1997 will be rewritten or rescinded in 2002). ECJ1-AA will provide OPRs with a listing of their publications that require rewrite or rescission during the upcoming year. The OPR must take action on these publications before 31 December of the anniversary year. Any publication not republished or rescinded by the OPR by 31 December of the anniversary year will automatically be rescinded by ECJ1-AA.

8. **Stockage of Publications.** The HQ USEUCOM Publications and Forms Section (ECJ1-AAP) will not maintain a stock of all unclassified USEUCOM publications, and all changes thereto. ECJ1-AA will not provide copies of USEUCOM publications that are available electronically unless the requester does not have access to the Worldwide Web or the SIPRNET. The OPR will maintain all non-distributed copies of SECRET and higher classified publications for which they are responsible. OPR of classified publications are responsible for providing copies to authorized users.

9. **Requesting Publications.** Account holders will requisition HQ USEUCOM publications and forms not available on the WORLDWIDE WEB or the SIPRNET from ECJ1-AAP. Account holders not physically located on Patch Barracks may requisition publications by electronic message or FAX.

10. **Electronic Publications.** Unclassified USEUCOM Publications and forms are available on the WORLDWIDE WEB. The WEB site for USEUCOM Publications and forms and links to other military publications and forms is:
